- 2.2. Extras: If you book any extras (additional baggage, insurance, etc.), you'll enter into a direct contract with the Third-Party Aggregator and/or the airline. We will not be involved in this contract.
- 2.3. We act solely as the Platform and are not involved in the Third-Party Terms. We are not responsible for your ticket or any extras you may buy and (to the fullest extent permitted by law) have no liability to you in relation to your Booking.
- 2.4. Changes and Cancellations: Airlines have different policies regarding modifications and cancellations. Fees may apply, and refunds are subject to airline policies.
- 2.5. Check-in and Travel Documents: Passengers must check in on time and carry valid travel documents, including visas where required. KINISIS TRAVEL LTD is not responsible for denied boarding due to missing documents.
- 2.6. Flight Delays and Cancellations: If a flight is delayed or canceled, compensation or alternative arrangements will be as per airline policies and applicable EU regulations (Regulation EC 261/2004).
